The World Championships will be knock-out tournaments, best of three first-to-six set matches. Seeding will be based on RTO handicaps at date of draw. If there are more than 32 entrants, a qualifier will be held. Please state if you prefer your entry to be withdrawn if you have to qualify. There will be a plate competition for first-round Singles and qualifier losers.

All players must be available to play at any time during the Championships. All entrants must be members of the LRTA if UK residents, or of the USCTA if US residents. World Championships rules will apply (these are available on the LRTA website) and all clothing on court must be predominantly white apart from shoes. Information regarding practice courts will be sent with the draw.

Entry fees are **£40** for the Singles and **£30** per player for the Doubles championships; under 21 years of age (as at 12<sup>th</sup> April 2015) **£20** and **£15** for Singles and Doubles respectively. The entry fee for the Handicap Doubles is **£25** and **£12.50** if under 21 years. There will be a discount if you wish to participate in all 3 competitions or just the Worlds Singles and Doubles. Professionals: no entry fees.

A Welcome Reception will be held on the evening of Monday 13th April (free for competitors, £10 for non-competitors), a Championships Dinner on Saturday 18<sup>th</sup> April (wine kindly donated by Wineflow) and a finals lunch on Sunday 19<sup>th</sup> April all at the Leamington Club. We hope all competitors and their friends will attend. The dinner will be £40 for competitors and £50 for guests (numbers limited so please apply now). Tickets for all attendees for the Finals Day lunch: £15. Light lunches and refreshments will be available at the club during the day.

The **closing date** for entries will be **Sunday 1st March 2015**. The draw will take place at Seacourt Tennis Club. If you wish to attend the draw, please request details.
